This amount includes remuneration for members with specific delegations or assignments, variable compensation, as well as any fringe benefits and end-of-term treatments, and will be distributed among the members as determined by a specific resolution of the Board itself.

It should also be noted that as of the deadline for the submission of lists, no other lists have been submitted for the appointment of the Company's Board of Statutory Auditors.
